



RELEASE AGREEMENT

I understand and agree to the following:

1. My dog is in good health and has not been ill within the last 30 days. I also agree that I will not bring my dog to the facility for daycare or boarding if he/she is exhibiting symptoms of illness. I understand that if my dog exhibits symptoms of illness while boarding or attending daycare that he/she will be removed immediately and will not be allowed to return until symptoms have ceased for a period of at least 24 hours. This precaution will be taken to protect all pets from contracting communicable illnesses or parasites and to decrease the risk of spreading illnesses.
2. All vaccinations are current and proof of Distemper, Parvo, Rabies, and Bordetella (kennel cough) is required prior to admittance into the facility. If any of these vaccinations are expired, my dog will not be able to be boarded or to participate in daycare. If my dog received his/her first bordetella vaccine, I understand that my pet must wait at least 7 days after it was administered before being allowed into the facility.
3. My dog must be flea and parasite free.
4. All dogs over 7 months must be spayed or neutered in order to participate in the daycare program.
5. Waggin' Tails Resort Inc. will perform a temperament test on ALL dogs prior to introduction into our group daycare. Temperament testing allows close supervision by a trained attendant who will assess the dog slowly being introduced into a playgroup. We will use the information provided by the client and then observed during the test to place the dog in the appropriate playgroup. We use our experience and training to place the dog in the appropriate group based on temperament, energy level and age. Waggin' Tails Resort Inc. reserves the right to refuse playtime to your dog if they show any aggressive behavior towards a fellow dog or human. Here at Waggin' Tails Resort Inc. we understand that, like people, dogs may have a bad day or don't play well with certain dogs. If this is the case, we may remove your dog from the group for a break or change your dog's type of boarding/daycare arrangement if we believe it is necessary to protect the health and well-being of your dog, other dogs, and/or our staff.
6. I understand the hours of Waggin' Tails Resort Inc. I understand that my dog will be boarded overnight if I am late to pick up my dog from daycare. Regular boarding rates will apply.
7. I understand that while Waggin' Tails Resort Inc. and its staff takes careful precaution and practices diligence to avoid injury or illness to my pet, these risks do exist and that I am financially responsible for the associated veterinary care if my dog is injured or becomes ill as a result of boarding and/or attending daycare. I understand that much like allowing a child to attend daycare or play a contact sport, risks of illness or injury are inherent and the associated medical costs are the responsibility of the parent (pet owner). I understand and agree that Waggin' Tails Resort Inc. and its staff are not liable for any accident or injury that may occur. Examples of potential illness or injury include, but are not limited to: bite wounds, lameness injuries, sore muscles/joints, fatigue, sore or abraded paws, intestinal parasites, oral papillomas, kennel cough or other infectious diseases. I understand the risk involved and that it will be my responsibility to take care of any vet charges. I understand and am encouraged to discuss any concerns I have with the Waggin' Tails staff before I sign this release.
8. Dogs at play during the regular day get dirty. Dogs with longer hair can get matted from the level of activity at daycare. Baths and brush outs can be requested and scheduled for an additional charge. Excessively long toenails may cause injury. I will be notified if my dog's nails are too long. If, at my next visit, the nails have not been trimmed, Waggin' Tails staff will have them trimmed at my expense.
9. Water is available at all times, however, my dog may still be thirsty after boarding or daycare.

10. Changes in food and/or food quality may cause upset stomachs and/or diarrhea. Increases in activity and/or exposure to new situations may also cause these problems.
11. Any behavior deemed dangerous or inappropriate by Waggin' Tails staff may result in dismissal of my dog(s) from the daycare program.
12. I hereby authorize the use of photos and/or information including vet records; related to my pet's experience at this facility. I understand my pet may be used in publications including electronic, audio visual, promotional literature, advertising, community presentations, media and/ or similar ways. My consent is freely given as public service without expecting payment. I release this facility and their respective employees from any and all liability which may arise from the use of such news media stories, promotional material, videos, or photographic images. I hereby grant permission to this establishment to use my pet's name and images.
13. Prepaid packages are NON refundable. Once a prepaid package has been purchased, you cannot receive a refund of any sort. The packages can be used for up to a year after purchase.

By signing this form:

- A. You indicate your agreement with the terms hereof.
- B. You understand that even though your dog is regularly vaccinated, those vaccinations cannot completely guard against illness and disease and, because of that, there is a chance that your pet can contract a health condition or be exposed to insect pests while in for services and you agree that Waggin' Tails Resort Inc. is not responsible for such illness or condition that may be contracted while in for services.
- C. You acknowledge that your pet hasn't been ill with any communicable condition in the last 30 days.
- D. You acknowledge that Waggin' Tails Resort Inc. accepts responsibility for the normal wear and tear damage that your pet may cause to business property, but agree that you will be responsible for any other damage, including but not limited to, damage or injury to other pets, people, or objects while your pet is in the care of Waggin' Tails Resort Inc.
- E. You agree that you have notified Waggin' Tails Resort Inc. whether your pet has harmed, shown aggression or exhibited any threatening behavior towards any person or other pet. You understand that Waggin' Tails Resort Inc. will not be responsible for injury or attack that your pet may inflict upon another person or pet.
- F. In the event of illness or injury to your pet, you authorize Waggin' Tails Resort Inc. to take your pet to your vet, if possible, or to the nearest or most suitable veterinarian deemed advisable by Waggin' Tails Resort Inc. You agree to pay all vet care required or advised necessary, in the opinion of the treating vet. Waggin' Tails Resort Inc. will make every effort to contact you. If you cannot be reached in a timely manner, you authorize Waggin' Tails Resort Inc. to use their best judgment in deciding whether to go ahead with any form of treatment recommended by the vet and you agree to pay for all such care.
